### Risk Assessment, Step by Step

#### About the workshop

How do you conduct a health and safety risk assessment? Using a workplace hazard chosen by the group as an example, this short workshop will take you through the practical steps needed to ensure that hazards are properly assessed and evaluated; and that you are meeting your legal duties towards others (including the public). It is aimed at anyone responsible for health and safety within their organisation.

#### **Outcomes**

By the end of the workshop, participants will:

- (a) Understand what is required to conduct a risk assessment.
- (b) Be aware of their organisation's duties towards staff, volunteers and the public.
- (c) Be more confident in applying best practice to health and safety.

#### The Trainer

David Green has extensive experience in the health and safety field, having previously been chair of the national Further Education Safety and Health Forum which brought together employers, trades unions and the Health and Safety Executive. He has run a number of courses on health and safety for small charities.

#### About the workshop

Place Making or Community Led Planning is a process where people come together to identify and take action on issues that are important to them.

This course is a practical approach to helping communities in Berwickshire organise and identify opportunities they want to explore or improvements they want to make. At the heart of all community development is meaningful engagement with the people who live, work or visit the place.

#### Outcome

A realistic plan for engaging with the people in your community and listening to their needs and aspirations.

Anne McNeill is a Trustee of A Heart for Duns and facilitates the Berwickshire Alliance. She grew up in Duns and returned to live in the area after a career as a consultant working internationally on business and economic development.



### **Data Protection Essentials**

#### About the workshop

What can you and can't you do with other people's personal data? This workshop looks at the key rules when it comes to collecting and using personal data; and the type of measures needed to keep such data safe. It will consider the essential elements of data protection law; and the secure handling of personal data. It will be of use to anyone in charities, the voluntary sector and social enterprises that handles personal data.

#### **Outcomes**

By the end of the workshop, participants will:

- (a) Understand what is and is not allowed, in terms of the law.
- (b) Understand the importance of, and steps needed to keep personal data secure.
- (c) Be more confident in applying best practice to data protection.

#### The trainer

David Green has been providing consultancy and delivering courses on data protection since before the introduction of the GDPR. He has written privacy notices and data protection policies; and helped organisation carry out internal data audits.

### **Emergency First Aid at Work**

This course is suitable for people who work or volunteer in low hazard environments (for example a community venue, office or shop), or where Health and Safety Executive (HSE) guidelines indicate staff should hold a certificate in emergency first aid at work.

It gives learners the skills and confidence to respond to a range of accidents and first aid emergencies they may encounter in the workplace.

Certificates are valid for three years.

- (a) Be aware of their duties and responsibilities in respect of safeguarding.
- (b) Know the practical measures they should be taking to ensure the effective management of safeguarding.
- (c)Be better placed to embed safeguarding into the culture of their organisation

## Data Protection for Trustees and Senior Staff

Online workshop

#### About the workshop

Fines for data breaches can be large, even when your own organisation is the victim of hackers. So, what should trustees and senior staff do to ensure compliance with data protection law? This workshop considers the principles of processing personal data, and in particular, the new principle of accountability. It looks at how you can meet your organisation's responsibilities; and the steps you can take to demonstrate compliance with data protection law.

It is aimed at members of trustee boards and senior staff in small charities, voluntary groups and social enterprises.

#### **Outcomes**

Participants will:

- (a) Be aware of the seven principles behind UK data protection law.
- (b) Understand your organisation's responsibilities when processing personal data.
- (c) Know what is needed to demonstrate compliance with the law.
